PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2011

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

NB: BEFORE COMPLETING THIS FORM, BIDDERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF B-BBEE, AS PRESCRIBED IN THE PREFERENTIAL PROCUREMENT REGULATIONS, 2011.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated to exceed R1 000 000 (all applicable taxes included) and therefore the 90/10 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS

2.1 "all applicable taxes" includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;

- 2.2 “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 “**B-BBEE status level of contributor**” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 “**comparative price**” means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less .
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 “**total revenue**” bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 “**trust**” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 “**trustee**” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right) \quad \text{or} \quad P_s = 90 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{\min} = Comparative price of lowest acceptable bid

5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

6. BID DECLARATION

- 6.1 Bidders who claim points in respect of B-BBEE Status Level of Contribution must complete the following:

THE APPOINTMENT OF A SERVICE PROVIDER TO DEVELOP AN ACCESSIBILITY AND SPATIAL OPTIMIZATION MODEL FOR THE DEPARTMENT OF SOCIAL DEVELOPMENT SOCIAL INFRASTRUCTURE DELIVERY

1. Purpose

The purpose of these terms of reference is to appoint a service provider to develop an accessibility and spatial optimization model for the Department of Social Development Social Infrastructure delivery.

2. Background

The mission of the Department of Social Development is to ensure the provision of comprehensive, integrated, sustainable and high quality social developmental services to help reduce vulnerability and poverty, and to create an enabling environment for sustainable development in partnership with those committed to building a caring society.

Planning for social infrastructure delivery is essential in order for the DSD to fulfil its mandate of providing sector-wide national leadership on social development. Spatial planning analyses the *de facto* situation to put plans into action for adjusting supply to current demand, but it also endeavours to *look ahead* and make timely provision for expected future demands. It is an ongoing process as the spatial environment is in a constant flux of change.

Facilities become obsolete and their locations dysfunctional due to urban growth and changes in population distributions. DSD Social infrastructure planning aims to develop an integrated system of optimally located facilities and services which addresses the needs of society. This can be achieved by co-locating facilities that should be in close proximity to each other, that benefit from economies of scale and optimize spatial accessibility. However, a regional perspective is required to minimize boundary effects and eliminate unnecessary duplication of services due to jurisdictional constraints.

3. Scope of work

The service provider is expected to complete the following:

3.1 Analyse the current social service delivery network in terms of its spatial accessibility and locational optimality and to make proposals for its improvement by addressing the following key matters which will form a baseline for future planning and service delivery.

- 3.1.1 Where is each of the different types of social service delivery facilities located?
- 3.1.2 What are the maximum capacities of each of these facilities?
- 3.1.3 Who and how many people have access to these facilities?
- 3.1.4 How far do people travel to these social services?
- 3.1.5 Are these facilities optimally located?
- 3.1.6 Is the current supply in terms of types and capacities sufficient to cope with the demand?
- 3.1.7 What changes are required to develop an integrated and optimally located system of service delivery facilities?
- 3.1.8 Where, what type and size of additional facilities are required?
- 3.1.9 Which facilities should ideally be closed, re-located or right-sized?

3.2 As one of the objectives is to develop an integrated system of service delivery nodes all types of social services as listed below will be included in a national study:

Service Facility Type

- Old age homes
- Service Centres for older persons
- Secure care centres
- Reform schools
- Drop-in centres
- Shelters for street children
- Partial care facilities
- Child and Youth Care Centres
- Schools of industry
- Temporary places of safe care
- ECD facilities
- Substance dependency treatment centres
- Halfway houses

- Residential facilities for people with disabilities
- Protective workshops
- Rehabilitation facilities for people with disabilities
- Shelters for victims of crime and abuse
- One Stop Development Centres
- Youth Development centres
- Offices

3.2 DSD will make available the following data:

- 3.2.1 The geographical locations and capacities of all social services in the RSA.
- 3.2.2 Definitions of the target populations for each of the social services to be analysed;
- 3.2.3 Accessibility norms and standards for each of the social services;
- 3.2.4 Estimates of prevalence or incidence with respect to the social needs that are to be serviced.

3.3 The service provider is expected to provide the following sets of data:

- 3.4.1 Most recent population statistics for the smallest available geographical areas, which include data on the fields required for identifying spatial demand for each of the social services listed (Age, income, marital status etc.)
- 3.4.2 Road and street network data.

4. Deliverables

The following deliverables are expected:

- 4.1 *A final report* that will describe the research process, methodology and results and make recommendations on the necessary steps required to implement the findings. The report will be in a printable PDF-format. It will contain tables, charts and maps which document the results in a simple, understandable, systematic and logical manner.
- 4.2 ESRI shape files with accurate *locational information of all the social service facilities and their attributes*. The tabular information will list the name, type, maximum capacity, demand at the location, average travel distance or time to the location for each facility etc. The table must also indicate what actions are required at the particular supply point, such as establishing new facilities, or right-sizing, relocation or closure.

- 4.3 ESRI shape files for *all demand locations with attribute information* on the size of the demand for the different types of social services, the travel distance/time to the closest facility and its name.

5. Facilities /resources

Departmental staff will be available for workshops and discussion provided sufficient notice is given for any proposed meeting.

6. Timeframe

It is anticipated that the project would not exceed 12 months.

7. Skills and Knowledge

The following range of skills is required from the service provider

- 7.1 Proven experience in developing optimal locality models.
- 7.2 An understanding of the Department's core business.
- 7.3 The team should have qualifications within the geographic information systems domain.

8. QUOTATION PROPOSAL

The proposal of prospective service providers must include:

- 8.1 Proposed methodology and approach that would be utilized in the completion of this task
- 8.2 Detailed costs of the tasks to be completed as per the scope of work

9. GENERAL CONDITIONS

- 9.1 The general conditions of contract as prescribed by National Treasury will be applicable in all instances.
- 9.2 All information, documents, programmes and reports must be regarded as confidential and may not be made available to any unauthorized person or institution without the written consent of the Accounting Officer or his delegate.
- 9.3 The Department will become the owner of all information, documents, programmes, advice and reports collected and compiled by the service provider in the execution of this project.
- 9.4 The copy right of all documents and reports compiled by the service provider will vest in the Department and may not be reproduced or distributed or made available in any other way without the written consent of the Department.

- 9.5 The Service Provider is entitled to general knowledge acquired in the execution of this agreement and may use it, provided that it shall not be to the detriment of the Minister of Social Development.
- 9.6 Should either party fail to carry out any of its obligations in terms of the agreement, then the other party shall be entitled to give the defaulting party notice to comply therewith within a period of 10 days. Should the other party fail to do so, then the other party may without prejudice to any other rights it may have, terminate the agreement without further notice. On termination of the agreement, for whatever reason, all documents, programmes, reports, etc must be handed to the Department, the Service Provider relinquishes the right of retention thereof.
- 9.7 The Department will furnish the Service Provider with all relevant and available data and information, which is necessary to perform the services under the agreement.
10. Payment will be effected within 30 days after receipt of a detailed invoice from the successful service provider.

11. EVALUATION CRITERIA

- 11.1 The evaluation of the bids will be conducted in two stages:
- a) Firstly, the proposals will be evaluated on functionality. An evaluation panel will allocate points (scale of 1 - 5) in respect of functionality according to the criteria set out in paragraph 11.4. Proposals scoring less than 60% in respect of functionality will be disqualified and not be evaluated further.
 - b) Thereafter, only the qualifying bids will be evaluated in terms of the 90/10 preference point system as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000).
- 11.2 The 90 points will be used to calculated price only and the 10 points will be used to calculate BBBEE status level of contribution.
- 11.3 The points in respect of price will be calculated on the ceiling price for the project (inclusive of professional fees, and VAT).
