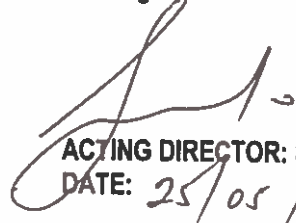

TERMS OF REFERENCE FOR PROCUREMENT OF INFORMATION COMMUNICATION TECHNOLOGY (ICT) MONITORING TOOL

1. PURPOSE

The purpose of this document is to request for proposals to supply the Department Social Development (DSD) for procurement of Information Communication Technology (ICT) monitoring tool.

2. PROJECT NAME

ICT Monitoring Tool.

3. BACKGROUND

The Department of Social Development (DSD) - Information Management and Systems Technology (IMST) provides IT services to the Department to enable it to do its business operations. IT services include provisioning of network connectivity, hosting infrastructure and business applications. The agility, availability and reliability of systems are key IT operational metrics to be met to ensure business operations 24/7/365.

4. PROBLEM STATEMENT AND CURRENT SITUATION

The Department is currently experiencing challenges which impact negatively on the ICT work flows which results in poor system performance and response time between the National Office and Provincial Offices. This challenge has ultimately affected the availability of Information Technology (IT) services including the critical business applications. The

Department therefore requests the service of experts in ICT Monitoring to provide a tool that will monitor the infrastructure and all applications.

The monitoring tool is required to monitor all network nodes for uptime of the service components for specific periods, including end-to-end applications performance, availability and configuration issues. The current absence of this tool limits the capability of providing effective oversight over network service components capacity which result in ICT being reactive rather than proactive to avoid service breakdown.

It is envisaged that the tool will provide DSD with a comprehensive, unified view of ICT to monitor resource availability and capacity usage, reducing downtime risk and helping to ensure a consistent, positive and stable user experience.

The tool is also expected to foster better collaboration and knowledge sharing among different disciplines of ICT such as Systems Development, Operations, Infrastructure and Security and as a result, issues alerts and recurring problems can be resolved pro-actively without unnecessary service disruption.

5. SCOPE OF WORK

5.1 The tool should be able to monitor, measure, manage, report and assist with capacity planning of the Department's entire physical and virtual assets across platforms (Windows, VMware, etc) applications, domains, and multiple data centres. The tool should be able to determine if bottleneck exist. The tool will be expected to provide a high standard service, adherence to set turnaround times with regards to fault resolution.

5.2 Visibility of ICT into Systems across the entire technology stack

When properly designed and implemented, the monitoring tool must provide the right levels of service provision management transparency. ICT officials must gain visibility into how systems are performing across the entire technology stack. ICT officials must be able to monitor systems performance for all users regardless of where they are located through any device.

If a performance problem arises, ICT officials envisage to be able to see exactly where the bottleneck lies within the technology stack including the network, servers, database,

and application code or end-user device. With this level of diagnostic insight, ICT officials will be able to address the technical root cause before end users are impacted.

In addition, the tool must also improve service delivery across the Department and its stakeholders, as the tool must greatly reduce the amount of unplanned work that comes with unplanned service disruptions.

5.3 Increase value of ICT to the Business

The Monitoring tool should enable deep insights into systems performance which will allow ICT officials to become more service-centric. The more visible the application environment, the more ICT officials will be able to ensure that its services meet the business needs. This will also provide context analytics which measures how applications and infrastructure impact the business and therefore helps to tie service performance directly to the business results. This capability will also make IMST more valuable by reinforcing strategic role in employee productivity and customer engagement while also driving service delivery.

5.4 Improve management of ICT costs

Monitoring tool is required to help ICT officials to manage costs better, as it can use its insights to better predict peaks and troughs in application consumption. Taking a strategic approach to performance management and using monitoring tool will be allowing ICT officials to consolidate technology-domain-centric tools. This will help eliminate redundancies and the need for specialized skills.

5.5 Proactive approach to ICT management

The Monitoring tool must be able to show developers how their code is performing whether they use agile or waterfall, etc design processes. This will help in meeting the business desired performance levels before systems are deployed. It will also help by sending alerts about slowdowns in production, ICT officials will be able to view real-time diagnostics which will help with proactive troubleshooting, easily monitor everything.

5.6 Automated Alert on problems before they happen

The monitoring tool is required to pro-actively monitor and predict or identify and alert the ICT officials before the incident happen (i.e. if you are about to run out of memory space,

there should be a measure that will be used so that once it is about to be reached then the alarm is triggered) by sending an SMS and an e-mail.

5.7 Isolate problems quickly

The monitoring tool must provide a dashboard view with drill-down analytics and reporting to root cause. Fast root-cause detection to stop recurring outages.

5.8 The service provider is expected to install the monitoring tool, as well as to conduct skills transfer to DSD - ICT officials on the functionality and configuration of the tool.

5.9 The tool should also be able to produce daily, weekly, monthly, custom and ad-hoc reports on Department's systems availability and performance.

5.10 Maintain and support the system for a period of (3) three years with the inclusion of being able to offer support on-site.

5.11 Provide formal training on the monitoring tool to the relevant ICT officials.

5.12 Installation and configuration of the monitoring tool.

5.13 Provide skilled resources that will plan, facilitate, implement and fully deploy the solution.

5.14 On-site Maintenance and support contract for three (3) years.

5.15 Provide the certified letters of accreditation for particular monitoring tool.

9. GENERAL CONDITIONS

9.1 The general conditions of contract as prescribed by National Treasury will be applicable in all instances.

10. OUTPUTS/DELIVERABLES

10.1 Monitoring tool software/ licence, hardware and regulatory licenses required.

10.2 Configured analytics, dashboard and reporting.

10.3 Provide All Documentation (inclusive of user Configuration and Manuals).

10.4 The expected outcome of this exercise is to provide detailed reports on ICT

environment, consisting, but not limited to the following:

- 10.4.1 Changes that occur on each application.
- 10.4.2 Space utilization on each server - how much is currently utilized and available.
- 10.4.3 Memory usage on each server- How much memory is being utilized and available.
- 10.4.4 Availability and performance of each application
- 10.4.5 Availability and performance of each server
- 10.4.6 Database availability and performance
- 10.4.7 Buffer Manager Statistics - Resolve all identified bottlenecks
- 10.4.8 Connection Statistics and Analytics - Number of users connected at the specific time, system, application and user metrics, etc.
- 10.5 Provide management to ensure successful implementation of the project
- 10.6 Provide Formal instructor-led training of eight (8) ICT officials with attendance certificates
- 10.7 . Provide information to the department that clearly outline the solution design and the department should be able to understand the solution,
