### 1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R1 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R1 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated to exceed R1 000 000 (all applicable taxes included) and therefore the 90/10 system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B-BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

### 2. DEFINITIONS

2.1 “**all applicable taxes**” includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;

- 2.2 “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- 2.3 “**B-BBEE status level of contributor**” means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 “**comparative price**” means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 “**consortium or joint venture**” means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 “**contract**” means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 “**EME**” means any enterprise with an annual total revenue of R5 million or less .
- 2.10 “**Firm price**” means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 “**functionality**” means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 “**non-firm prices**” means all prices other than “firm” prices;
- 2.13 “**person**” includes a juristic person;
- 2.14 “**rand value**” means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 “**sub-contract**” means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 “**total revenue**” bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 “**trust**” means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 “**trustee**” means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

### 3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

### 4. POINTS AWARDED FOR PRICE

#### 4.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$P_s = 80 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right) \quad \text{or} \quad P_s = 90 \left( 1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

$P_s$  = Points scored for comparative price of bid under consideration

$P_t$  = Comparative price of bid under consideration

$P_{\min}$  = Comparative price of lowest acceptable bid

### 5. Points awarded for B-BBEE Status Level of Contribution

- 5.1 In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below:

- 5.2 Bidders who qualify as EMEs in terms of the B-BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA's approval for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates.

## Terms of reference

**The appointment of a service provider to develop norms and standards as well as blueprint architectural designs for 25 different types of facilities within the Social Development sector.**

### 1. Purpose

The purpose of these terms of reference is to appoint a service provider to develop norms and standards and blueprint architectural designs for 25 facilities within the Social Development sector.

### 2. Background

The mission of the Department of Social Development (DSD) is to ensure the provision of comprehensive, integrated, sustainable and high quality social developmental services to help reduce vulnerability and poverty, and to create an enabling environment for sustainable development in partnership with those committed to building a caring society.

Under ideal conditions, the planning for infrastructure delivery and management in the government sector is complex and challenging. Under the circumstances of a changing landscape and service delivery system combined with ever-increasing pressure for social services, planning became even more challenging to the Department of Social Development.

In order to ensure that there is uniformity within the DSD sector, the Department requires norms and standards for each facility type in order to ensure that any new building would be built according to a standard. Furthermore, these norms and standards should form the basis for blueprint architectural designs for each facility.

The DSD sector currently has the following in place:

- 1.1 Design guidelines for all facilities;
- 1.2 Legislative service delivery norms and standards; and
- 1.3 All provinces have architectural designs and bills of quantities of facilities listed in Table 1 that they have built.

Table 1 below is an indication of the type of facilities that will be included in the project. It can be assumed that the minimum size of each facility will be 60 and maximum 120 persons.

### 3. Scope of work

**The service provider is expected to analyse the current design guidelines available for DSD facilities, legislative service norms and standards and architectural designs developed by the provinces. Furthermore, the service provider is expected to conduct some site visits of facilities within the provinces to view “best practise” designs.**

- 3.1 Review all policies and legislation that relate to programme norms and standards and infrastructure matters within the department.
- 3.2 Complete norms and standards for each facility. These should include the following sub sections:
  - Space norms and standards
  - Occupational health and safety
  - Security standards
- 3.3 Blueprint architectural plans
  - Designs for each facility which must factor “green building” principles
  - 3D models for each facility
  - Specifications for all internal fittings and fixtures within the building for each facility type (e.g., doors, windows etc).
- 3.4 Develop a costing model for each facility based on an analysis of the norms and standards and designs developed.
- 3.5 Make a recommendation for any alternate building material option that would be feasible for a particular facility.
- 3.6 Facilitate one national workshop for presentation of the norms and standards and designs

#### **4 Deliverables**

The service provider is expected to deliver:

- 4.1 Establish a minimum uniform national norms and standards for all facilities
- 4.2 Individual norms and standards reports for 25 facilities which incorporate space, occupational health and safety and well as security standards;
- 4.3 Blueprint architectural designs for 25 facilities with 3D drawings and documented specifications for all fittings and fixtures included in the facility.
- 4.4 A cost model based on the norms and standards and architectural designs based on options of brick and mortar and alternate building material.

#### **5 Facilities /resources**

Departmental staff will be available for workshops and discussion provided sufficient notice is given for any proposed meeting.

#### **6. Timeline**

It is anticipated that the project should not exceed more than 12 months.

#### **7. Skills and Knowledge**

The following range of skills is required from the service provider

- 7.1 Proven experience in completing norms and standards. Experience of completing norms and standards within the built environment will be an advantage.
- 7.2 Architectural skills and registration with a professional body.
- 7.3 Engineering/Quantity surveying and project management skills.
- 7.4 Financial costing skills.
- 7.5 A broad understanding of the Public Finance Management Act, 1999 (No 1 of 1999) as amended (PFMA), Treasury Regulations and Division of Revenue Act

#### **8. QUOTATION PROPOSAL**

The proposal of prospective service providers must include:

- 8.1 Proposed methodology and approach that would be utilized in the completion of this task
- 8.2 Detailed costs of the tasks to be completed as per the scope of work

#### **9. GENERAL CONDITIONS**

- 9.1 The general conditions of contract as prescribed by National Treasury will be applicable in all instances.

- 9.2 All information, documents, programmes and reports must be regarded as confidential and may not be made available to any unauthorized person or institution without the written consent of the Accounting Officer or his delegate.
- 9.3 The Department will become the owner of all information, documents, programmes, advice and reports collected and compiled by the service provider in the execution of this project.
- 9.4 The copy right of all documents and reports compiled by the service provider will vest in the Department and may not be reproduced or distributed or made available in any other way without the written consent of the Department.
- 9.5 The Service Provider is entitled to general knowledge acquired in the execution of this agreement and may use it, provided that it shall not be to the detriment of the Minister of Social Development.

Should the other party fail to do so, then the other party may without prejudice to any other rights it may have, terminate the agreement without further notice. On termination of the agreement, for whatever reason, all documents, programmes, reports, etc must be handed to the Department, the Service Provider relinquishes the right of retention thereof.
- 9.7 A response to each element in the evaluation matrix (as set out in paragraph 10) include annexures, but the response to each element must be **summarized in no more than 6 pages**.
- 9.8 The Department will furnish the Service Provider with all relevant and available data and information, which is necessary to perform the services under the agreement.
10. Payment will be effected within 30 days after receipt of a detailed invoice from the successful service provider.

## 11. EVALUATION CRITERIA

- 11.1 The evaluation of the bids will be conducted in two stages:
  - a) Firstly, the proposals will be evaluated on functionality. An evaluation panel will allocate points (scale of 1 - 5) in respect of functionality according to the criteria set out in paragraph 11.4. Proposals scoring less than 60% in respect of functionality will be disqualified and not be evaluated further.
  - b) Thereafter, only the qualifying bids will be evaluated in terms of the 90/10 preference point system as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000).
- 11.2 The 90 points will be used to calculated price only and the 10 points will be used to calculate BBEE status level of contribution.

11.3 The points in respect of price will be calculated on the ceiling price for the project (inclusive of professional fees, and VAT).

11.4 Technical proposals will be evaluated on a scale of 1-5 in accordance with the criteria below. The rating will be as follows:
